## Can I Add A Baby To An Existing United Airlines Reservation?

To add a baby to an existing United Airlines reservation, contact them over the phone or connect with the consolidation desk at + 1~(844)-325-4646 (OTA). If you want to do it online, go to the official website, log in to your account, and go to the “Passenger Details” page. Here, choose the option “Add infant in lap,” and your process is done. ## Can I Add A Lap Child At the Last Minute On United Airlines?

To learn how to add a lap child at the last minute on United Airlines, call the airline at + 1~(844)-325-4646 (OTA). However, before beginning the process, ensure that the baby is under two years old and you are carrying only one lap infant. The airline only permits one lap infant per adult. ## How To Hold A Baby On Domestic United Airlines?
